**Letter of Authority for Shipping Company to Deal with Named Agent**

Dear Sir,

Please be informed that we have appointed [insert name of Agent] Unity Int'l Cargo Pty Ltd

In respect to such consignments of goods, this letter specifies the terms upon which we have granted authority to the Agent -

1. The Agent to request to receive copies of Arrival Notices for specific shipments.
2. The Agent to request delivery from the Shipping Company of goods consigned or endorsed to us under original bills of lading, and consigned to us under sea waybills.
3. We expressly authorise and instruct the Shipping Company to release our goods to the Agent upon presentation of an original bill of lading, or identification against a sea waybill of lading, unless we have given seven (7) days' prior written notice to the contrary to the Shipping Company.
4. We expressly warrant the authority of and the authenticity of any identification presented to take delivery in the name of the Agent on our behalf. We warrant that the Agent shall have sufficient and proper authority and capacity to validly and effectually bind us and hereby undertake to ratify any and all actions of the Agent and shall be liable for all acts and omissions by the Agent, whether arising under contract (including indemnity), tort (including negligence), statute by means of strict liability or otherwise.
5. We expressly authorise the Agent to request Import charges from the Shipping Company.
6. In consideration of your agreeing to comply with our request above, we hereby agree and undertake to indemnify all of you and hold all of you harmless in respect of any liability, loss, damage or expense of whatsoever nature howsoever arisen which any of you may sustain in connection thereof.

The validity of this letter of authority will continue subject to 30 days' written notice of termination or presentation of a new Letter of Authority by us to the Shipping Company.
